

Put Prevention First

SUPPORT HB 1914 (Del. Ward), HB 2035, (Del. Hamilton), HB 2877 (Del. McEachin) and SB 1230 (Sen. Howell): HPV vaccination requirement and coverage

In June 2006, the Food and Drug Administration (FDA) approved Gardasil, a vaccine that can protect women against the most virulent strains of HPV that cause 70 percent of cervical cancers. Unfortunately, this life-saving vaccine is very expensive; a series of three shots administered within a six-month period costs approximately \$360.

HB 1914, HB 2035 and SB 1230 would add the HPV vaccine to the Virginia Board of Health's list of required immunizations for attendance at a public or private elementary, middle or secondary school, child care center, nursery school, family day care home or developmental center. As with other immunization requirements, the HPV requirement would include an opt-out option for parents who object to vaccinations for religious or other reasons.

HB 2877 would require health insurance to provide coverage for HPV vaccinations for women in accordance with recommendations of the Center for Disease Control's Advisory Committee on Immunization Practices.

Why Support HB 1914, HB 2035 HB 2877 and SB 1230?

- The best way to eradicate cervical cancer is widespread HPV vaccination. The most successful immunization programs, such as those for small pox or polio, require vaccination.
- Given the high cost of the HPV vaccine, adding it to the list of required immunizations is critical to making the vaccine accessible through coverage by private health insurers and government vaccination programs.
- Hispanic and African American women are approximately 1.5 times more likely to develop cervical cancer than white women, and are also more likely to die as a result.^{1,2} For populations that also experience disproportionate rates of poverty, coverage by private health insurers and government vaccination programs is the key to preventing cervical cancer.

In Virginia

- Between 1998 and 2002, about 300 women in Virginia were diagnosed with invasive cervical cancer annually, for a rate of 7.9 cases per 100,000 women, slightly lower than the national rate of 8.7 per 100,000.³
- Prevention of cervical cancer has widespread and bi-partisan support among state legislators: Gov. Tim Kaine's proposed budget includes \$1.4 million to supply local health departments with the vaccine and in November Lt. Gov. Bill Bolling launched his *Ending Cervical Cancer in our Lifetime* initiative for public awareness about cervical cancer.
